The committee discussed the changes proposed by Mr. Frizzell. After discussion the Committee voted to approve the language as presented with a minor change to paragraph (1) to read "579 or less" rather than "between 300 and 579."

The Committee determined that the following:

- 1. That the proposed rule amendment will have no adverse impact on small businesses or small counties.
- 2. That the proposed rule amendment will not be likely to directly or indirectly increase regulatory costs to any entity (including government_ in excess of \$200,000 in the aggregate in Florida within 1 year after implementation.
- 3. That no portion of this rule should be designate a minor violation.
- 4. That this rule reflects mandatory rulemaking, therefore the Committee voted to not include sunset language.
